






Source-Drain Diode Forward Voltage




Threshold Voltage




 V_{DS} - Drain-to-Source Voltage (V) $\label{eq:capacitance}$

On-Resistance vs. Junction Temperature





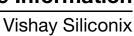
Safe Operating Area



Normalized Thermal Transient Impedance, Junction-to-Case

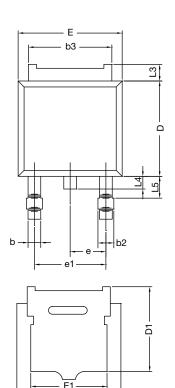



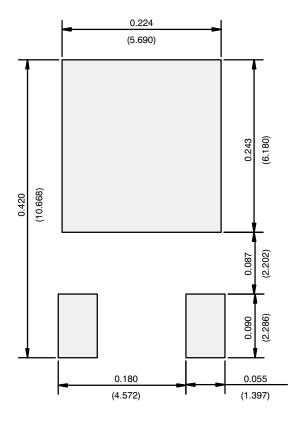
